The articles and slides may be presented in Armenian, Russian and English. Simultaneous translation will be provided when presenting the articles in Armenian or Russian.

All the presented articles will be included and published in the collection of **Conference Proceedings** with the ISBN international standard after double-blind anonymous review process. # **GUIDELINES FOR SUBMITTING ARTICLES**

- The abstract of the submitted paper should be presented in advance (**by 24 February 2023**) and should be maximum of two pages / not exceeding 500 words and include 5-7 keywords/. It should be structured in the following format: title of the article, keywords, the name of the author/authors, surname, patronymic, academic degree and title, associated scientific institution, author's e-mail address, telephone number.
- After sending the abstract the author/authors will receive a notification on confirmation of acceptance (by 3 March 2023). In case of the thematic and content inconsistency of the presented abstracts with the title and directions of the conference, as well as non-compliance with technical requirements and deadlines, the author/authors will not receive a confirmation of acceptance of the abstract and the submitted application for participation in the conference will be rejected by the editorial committee.
- The submitted paper /article as well as its separate parts must not have been published, presented or having been submitted for publication in other conferences or scientific journals.
- After receiving the confirmation of acceptance of the abstract, the full article must be submitted (by 15 April 2023). It should be structured in the following format: title of the article, name of the author/authors, surname, patronymic, scientific degree and title, scientific institution, e-mail address and phone number of the author/authors.
- The sections presented below are mandatory in the paper, if necessary, the content of the article can be divided into separate sections each with their subheadings:
  - ✓ Annotation (100-200 words)
  - ✓ Keywords (5-7 words)
  - ✓ Introduction (100-200 words)
  - ✓ Literature review (200-800 words)
  - ✓ Research methodology (150-500 words)
  - ✓ Analysis (1000-1500 words)
  - ✓ Conclusion (100-200 words)
  - ✓ Literature

Technical requirements:

Font: Times New Roman, font size: 12, line spacing: 1.5, page size: A4, margins: left: 3

cm, right: 1.5 cm, top: 2 cm, bottom: 2 cm, the references are in the footnotes, according

to the following sequence: source author, title, place of publication, year (in case of a

periodical, also the number) and page. Only the sources containing online links are given

in full (link).

The charts and tables presented in the article should be numbered and have the possibility

of editorial intervention. The chart titles are listed at the bottom, tables at the top.

It is necessary to present the articles electronically, in Microsoft Word format by

indicating "ASUE Scientific Conference" in the purpose field.

Submitted articles will be sent to double-blind peer review by two independent experts,

and only in case of positive opinions they will be published in the collection of the

conference materials.

The Organizing Committee does not inform the author/authors about the changes and reductions

of the presented article, which are of an editorial nature and do not affect the principle provisions.

The decision of the Organizing Committee on acceptance or rejection of the submitted article for

publication is final.
