SUBMISSION AND DECISION

Authors can participate in the conference:

1. **With an abstract (MICEB Book of Abstracts), or**
2. **With a full paper (see publication opportunities).**

Submitted abstracts written in English should comply with the format of the Conference Instruction for Authors, must not have been published before and not be under review for any other conference or publication. Based on Scientific Committee evaluation, an abstract can be rejected or accepted by the Conference Chairs.
