About the conference and the event

The international conference “Sustainable South and Eastern Europe 2030+: Tackling Socioeconomic Transitions through the SDGs” aims to provide a multidisciplinary platform for discussion and exchange of ideas on the key socioeconomic transformations affecting countries in South and Eastern Europe in the context of the United Nations Sustainable Development Goals (SDGs).

The conference responds to the growing need to accelerate the implementation of the 2030 Agenda for Sustainable Development, especially in light of recent global initiatives such as the United Nations Summit of the Future, which emphasizes strengthening international cooperation and shaping the policy framework beyond 2030.

Countries in South and Eastern Europe face a range of complex challenges related to demographic change, regional disparities, energy transition, digital transformation, institutional capacity, and economic restructuring. Addressing these issues requires interdisciplinary research, evidence-based policymaking, and stronger cooperation between academia, policymakers, and the business community.

The conference is organized within the framework of the ASECUCU initiative “ASECUCU for the FUTURE”, which promotes national and regional events across the network of economic universities in South and Eastern Europe and the Black Sea region. The Bulgarian event hosted by the University of National and World Economy aims to contribute to this initiative by fostering dialogue between universities, public institutions, businesses, and civil society organizations.

The event will combine policy dialogue and academic research presentations, providing opportunities for both scholarly discussion and practical policy exchange.

OFFICIAL LANGUAGE of the conference is English.

SUBMISSION GUIDELINES

Authors are invited to submit an **extended abstract (2–5 pages)** in English presenting the main idea, research question, and expected or preliminary results of their research.

Each submission should include:

- title of the paper
- author(s) names, affiliations and contact information
- JEL classification codes
- 3–5 keywords

Extended abstracts should be submitted in **Word format**.

The extended abstract should follow a simple structure including:

Introduction (including research question/objectives)
Methodology / approach or analytical framework (where relevant)
Main findings or expected results
Brief list of references

Detailed instructions for the preparation of full papers will be provided after the acceptance of extended abstracts.
